
Field Diagram Supplement

To fully review your application for coverage a rough diagram of your paintball field / facility is required. The following items should be included:

1. Size of field. Square foot or number of acres. _____
2. Play area. Outline the field of play.
3. What type of field do you have? Woods fields, speedball, etc...
4. Landmarks – Netting, staging / briefing area, chronograph area, safety signs, Pro Shops, concession stands, storage sheds, Spectator area, parking, natural or man-made hazards, etc.
5. Indicate distance between landmarks.
